

ORDINANCE NO. 2103

**AN ORDINANCE AMENDING THE NORTHPORT CODE
TO EXEMPT CERTAIN "COVERED ITEMS" FROM THE MUNICIPAL
SALES AND USE TAX FROM 12:01 A.M. ON FRIDAY, FEBRUARY 25,
2022 AND ENDING TWELVE MIDNIGHT ON SUNDAY,
FEBRUARY 27, 2022 AS AUTHORIZED BY ACT 2012-256, GENERALLY
REFERRED TO AS THE STATE SALES TAX HOLIDAY LEGISLATION.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHPORT
AS FOLLOWS:**

1. Section 66-78 of the Code of Ordinances of the City of Northport is amended as follows:

Section 66-78. Sales Tax Holiday

(a) In conformity with the provisions Act 2012-256 enacted by the Alabama Legislature during the 2012 Regular Session, providing for a State Sales Tax Holiday, the City of Northport exempts "covered items" from municipal sales tax during the same period, beginning at 12:01 a.m. on Friday, February 25, 2022 and ending at twelve midnight the following Sunday, February 27, 2022.

(b) This section shall be subject to all terms, conditions, definitions, time periods, and rules as provided by Act 2012-256, except that the time period shall only be as specified in subsection (a) and not for all years thereafter.

2. Section 66-79 of the Code of Ordinances of the City of Northport is amended as follows:

Section 66-79 Use Tax Holiday

(a) In conformity with the provisions of Act 2012-256, enacted by the Alabama Legislature during the 2012 Regular Session, providing for a State Sales Tax Holiday, the City of Northport exempts "covered items" from municipal use tax during the same period, beginning at 12:01 a.m. on Friday, February 25, 2022 and ending at twelve midnight the following Sunday, February 27, 2022.

(b) This section shall be subject to all terms, conditions, definitions, time periods, and rules as provided by Act 2012-256, except that the time period shall only be as specified in subsection (a) and not for all years thereafter.

IT IS FURTHER ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHPORT, ALABAMA AS FOLLOWS:

3. The City Administrator is hereby authorized and directed to certify a copy of this ordinance under the seal of the City of Northport, Alabama and to forward said certified copy to the Alabama Department of Revenue to be recorded and posted on the Department website.


4. This Ordinance shall become effective on November 1, 2021.


