ORDINANCE NO. 2011-_____

ORDINANCE AMENDING SECTION 10-26 REGARDING THE SALE OF ALCOHOLIC BEVERAGES PROHIBITED DURING CERTAIN HOURS

WHEREAS, the State of Alabama passed Act No. 2011-120, allowing the legal sale and distribution of alcoholic beverages within the City of Northport on Sunday from 12:00 p.m. (noon) and 9:30 p.m., and on those Sunday on which occurs New Years Eve (December 31st) after 12:00 p.m. (noon), upon the approval by the voters in the City of Northport by an election pursuant to that Act.

WHEREAS, the City of Northport conducted an election on August 23, 2011, pursuant to Act 2011-120, and the voters of the City of Northport approved the sale of alcoholic beverages during certain hours on Sundays;

WHEREFORE, the City of Northport hereby amends Section 10-26 of the Code of the City of Northport to read as follows:

“Section 10-26 – Sale of Alcoholic Beverages prohibited during certain hours.

(a) *On-premises consumption.* It shall be unlawful for any person to sell or offer for sale, or to serve or dispense for rewards, or to consume or permit to be consumed on a licensed premises for on-premises consumption, any alcoholic beverage, including but not limited to beer, wine and liquor, in any alcoholic beverage licensed place, or elsewhere in the city, as follows:

Monday prior to 6:30 a.m. (except when Monday falls on January 1);
Tuesday through Friday between the hours of 1:45 a.m. and 6:30 a.m.;
Saturday between the hours of 2:45 a.m. and 6:30 a.m.;
Sunday between the hours of 2:00 a.m. and 12:00 (noon) and after the
Hours of 9:30 p.m. (except when Sunday falls on December 31);
Sunday, December 31, between the hours of 2:00 a.m. and 12:00 (noon);
Monday, January 1, between the hours of 1:45 a.m. and 6:30 a.m.;
unless otherwise permitted by State law.

(b) *Off-premises consumption.* It shall be unlawful for any person to sell or offer for sale on a licensed premises for off-premises consumption any alcoholic beverage including, but

not limited to, beer, wine and liquor, in any alcoholic beverage licensed place, or elsewhere in the city, at anytime on Sunday between the hours of 2:00 a.m. and 12:00 (noon) and after the hours of 9:30 p.m. (except when Sunday falls on December 31).

Sunday, December 31, between the hours of 2:00 a.m. and 12:00 (noon);
unless otherwise permitted by State law.

This ordinance shall be effective immediately upon passage by the City Council and approval by the Mayor.
