# NORTHPORT CITIZEN AWARD

## RULES TO BE OBSERVED

This award is sponsored by The City of Northport, Northport, Alabama and is presented at the annual Northport Citizen Awards Dinner in October of each year.

Northport is a thriving and growing community, and many of its citizens are contributing toward this growth. The purpose of this award is to focus on achievements made by Northport citizens involved in making Northport a better community.

Nominees will be judged in answer to the primary question: "What outstanding contributions has the nominee made to benefit the general welfare or growth of Northport?"

### **Criteria for Nominations Are Outlined Below:**

1. Nominations may be made by a civic, social, educational, business, or religious group or by an individual who is a legal resident of Northport.
2. The Official Nomination Form, supplied by Citizen of the Year Committee, must be used; all information **must be typewritten/keyboarded**.
3. No more than two (2) letters of recommendation may accompany the nomination.
4. The nominee must have been a legal resident of Northport for at least five years and must be a current resident of Northport.
5. The nominee must have made a significant contribution to the civic, social, religious, political and/or community growth of Northport outside his/her related job or elected responsibilities.
6. The deadline for returning nominations to The City of Northport as established by the Northport Citizen of the Year Committee will be strictly enforced. Deadline is listed on the nomination form.
7. The Voting Committee, appointed by the Citizen of the Year Committee, shall cast their votes by secret ballot. The ballots will be tabulated by the Committee and the results will be announced as soon as votes are tabulated. The winner is invited to attend the banquet along with his/her family. (Relatives of nominees are not allowed to vote)
