Todd Masterson, McGiffert and Associates, LLC, 2814 Stillman Blvd, Tuscaloosa, AL appeared before the commission representing 1871, Inc. stated he would like to make a correction. He stated it's going to be a two Lot subdivision not one. The road proposed was split. (Lot 1R and Lot 2R) but will remain a 2 Lot subdivision. The lot line will be moved to the right of us.
