**A RESOLUTION APPOINTING AN ELECTION MANAGER,
ABSENTEE ELECTION MANAGER, AND ELECTION COMMITTEE**

WHEREAS, the 2020 Northport municipal elections will be held on August 25, 2020; and

WHEREAS, there are numerous election duties that must be carried out by the Mayor, and the Mayor's designee, as set forth by state code; and

WHEREAS, if the mayor is a candidate for re-election, the mayor is disqualified from performing these functions; and

WHEREAS, the City Council has the authority to appoint some disinterested person to perform these duties and set out in Section 11-46-37 of the Alabama Code; and

WHEREAS, the City Council wishes to appoint the Interim City Clerk as the Mayor's designee, an Election Manager, an Absentee Election Manager, and an Election Committee to assist with the upcoming municipal election to the fullest extent as allowed by Alabama law.

NOW, THEREFORE, BE IT RESOLVED, by the City Council for the City of Northport as follows:

1. The Interim City Clerk, Warren H. McCollum, is hereby designated the Mayor's designee for the upcoming City Election.
2. That Whitney DuBose is hereby appointed as Election Manager as provided by Section 11-46-37 of the Alabama Code.
3. That Carrie Cameron is hereby appointed as Absentee Election Manager as provided by Section 11-46-57 of the Alabama Code.
4. That Whitney DuBose (chair), Carrie Cameron (Absentee Manager), Darren McGee, Kim Braughton, Jordan Brown and Julie Ramm will serve as Election Committee members and City Attorney Ron Davis will serve as an ex-officio member of the committee.
5. These individuals and committee members shall perform these duties to the fullest extent as allowed by Alabama law.
